TRUSTEES' REPORT 2018

Our aims and purposes as a charity

The PCC has the responsibility, along with Revd Matthew Luff, of:

- The promotion of the gospel of the Lord Jesus Christ according to the doctrines and practices of the Church of England
- Engaging with our local community
- Providing Christian teaching to all age groups through Sunday services and mid-week small group activities

What we plan to do to achieve our charitable objectives

When planning our activities for the year, we have considered the Charity Commission's guidance on public benefit and, in particular, the specific guidance on 'charities for the advancement of religion'.

For 2018 we discussed and planned the following objectives and activities to fulfil our aims:

- Providing accessible worship, to enable as many people as possible to participate in worship
- Engaging with our local community through our Love outhbourne activities
- Developing a new Families and Youth Ministry within the Parish
- Providing Christian teaching to all age groups through Sunday services and mid-week small group activities
- Provision of pastoral care for people living in the parish
- Giving grants to missionary organisations and Christian charities
- Maintaining contact with non-church goers through our daily coffee shop, 'Coffee Connect', Love Southbourne and by hosting village events
- Refitting the kitchen in the Church Centre for Church family and village events.
- Maintaining the church and the grounds as a focus of village life

What we achieved and how we affected beneficiaries' lives

Attendance at worship

The church family welcomes visitors from the locality and those visiting the area. We are always delighted to welcome those who have chosen to attend our worship and take part in our services of worship. We firmly believe that the provision of services of worship is a major public benefit of our activities.

Teaching, baptising and nurturing new and existing believers

In 2018 St John's was awarded a grant from the diocese to assist in funding a new Family and Youth Ministry within the Parish. We welcomed Richard and Kim Carter as Family & Youth Ministers (job share) in September 2018 and they are developing our programme for young in Southbourne.

We have around a dozen homegroups who meet on a regularly share and nurture each other's faith. It is encouraging that we have started another new group this year.

As a church family we have met together on various occasions to share food and fellowship, including a games night, football world cup events with a bbq and a fundraising quiz evening for Tear Fund.

Provision of the church building and grounds for people to enjoy

We celebrated 14 baptism, 2 weddings and 5 funerals in our churches during the year. During the day the churches are both open for parishioner and visitors for prayer and reflection; it is pleasing to see that many take advantage of

this opportunity.

During the year we have made our buildings and ground available for village events. Within the parish the Sussex Fete Day hosted by the St John's has become a popular annual event.

St John's has welcomed Little Stars Nursery, Southbourne Infant and Junior Schools to the church for Harvest and Christmas Services. In addition, we have led assemblies at the local infant and primary schools.

St Nicholas' church, dating from the 12th century, is a local landmark situated on the shore of Thorney Island in Chichester Harbour. In 2018 the final stage of renovation at St Nicholas' church was completed with the repair of the east gable. This was the culmination of 13 years work; a service of thanksgiving was held in October to mark this occasion. A new exhibition was created in the Vestry with a display recounting some of the history of the Island and the Church. A website remains a continuing resource for adding local stories.

Engaging with our local community

St. John's Church is committed to our local community, our neighbours, schools, families and friends. Located in the centre of the village of Southbourne we are ideally placed to use our buildings and grounds to engage with the local community. Our regular activities include toddlers, children and youth groups; book and film groups and events for seniors.

We continued to develop our Love Southbourne programme with a children's party in August, a second harvest fun day as well as Easter and Christmas events. These events continue to be popular in the village, bringing the community together on the recreation grounds in the north of the parish. The harvest fun day was attended by about 450 people; the facebook post was viewed by over 4,700 people.





In the autumn we also carried out major redevelopment on the church centre kitchen. The new larger, catering standard kitchen will enable us to offer food and fellowship at events for the local community, building on our popular coffee shop, Coffee Connect.

Future Projects

In 2019 we will continue to develop the work of the Family and Youth Ministry. The new kitchen will enable us to offer meals to the local community e.g. light lunches after toddler groups, curry evenings, Valentine's day suppers for couples.

The Love Southbourne community programme for 2019 includes an Easter Fun Day, August children's party and Christmas carol singing events.

We will be offering

Provision of pastoral care for people living in the parish

The Pastoral team coordinates hospital visits and home communions. The parish also holds a regular services in two care homes and has now started working closely with a third. These services are an important aspect in the lives of those who are too frail to attend services.

Ministry to the Thorney Island community

With the support of Army Chaplains, regular Sunday worship is held in St Nicholas, which continues to host baptisms, weddings and funerals for the Thorney Island community.

Provision of support to the poor and needy

The gifts from our Harvest Festival were distributed to the Food Bank; the church supports the Food Bank as a point of collection for food donations and also as an emergency distribution point for food parcels. During the year the church also gave to the charities listed below.

Other charitable giving

The parish tithes our income and gives 10% of our income to charitable and missionary causes. Our Mission team prayerfully considers the donation of these funds. In 2018 we supported a wide range of organisations including: 2serve, Emmanuel International, The Mande family, Education West Africa, Concordis, Callum and Rhianne Adams, Japan Link, Filling Station, Life Words, FEBA, Bereaved Family Holiday, BEATS, British Legion, MAF, Children's Society, Stone Pillow, Street Pastors and Through the Roof.

Safeguarding

The PCC has due regard to the House of Bishops' Safeguarding Policy and Practice Guidance on safeguarding children and vulnerable adults. A PCC member is Safeguarding Officer for the parish and ensures that we comply with best practice. This year we have implemented the diocese's new safeguarding programme 'Simple Quality Protects' (SQL).

2018 Financial Review

The church prepares accruals accounts for the calendar year with an independent examination in accordance with Charity Commission guidance. We are very grateful to Kent Mason for performing the independent examination. As our income has exceeded £250,000 this year (due to a £71,900 Heritage Lottery Fund grant for repair of St Nicholas') it has been necessary to engage an examiner with relevant accounting qualifications.

We are pleased to see that St John's committed giving has reversed the negative trend of previous years and shows a healthy increase of 11% in 2018. This is in addition to the £10,315 given by church members specifically for the kitchen refurbishment. Whilst it is very encouraging to see an increase in giving it should be noted that our giving remains insufficient to cover the cost of the Family Ministry and Youth team once the grant has been used up. The Diocesan Mission Funded has given us a grant of £40,000 spread over 2018, 2019, and 2020 to help towards the

Family and Youth Ministry team costs. It is estimated that a further increase in giving of 4% above inflation is required for the next few years to continue this ministry and maintain an adequate reserve.

The cost of refurbishment of the kitchen has been covered by:

General church funds	£11,800
Coffee connect funds	£10,000
Grants	£4,550
Specific donations	£10,315
Gift Aid (to be recovered)	£ 900

Trustee expenses and payments have been carefully controlled and reported in the published accounts in accordance with Charity Commission guidelines.

Two grants were awarded from the Timothy Trust this year in line with the aims of the trust.

The minimum reserves level of £25,000 decided by the PCC has been maintained. The St John's cash balance remains well above the reserve level at present.

Structure, Governance and Management

The Parochial Church Council (PCC) is registered with the Charity Commission as required by the Charities Act 2011. Its governing document is the Parochial Church Council (Powers) Measure 1956.

1 Accounting policies

a Accounting convention

The financial statements have been prepared under the Church Accounting Regulations 2006 in accordance with applicable accounting standards and the current (2015) Statement Of Recommended Practice, Accounting and Reporting by Charities SORP (FRS 102).

The financial statements have been prepared under the historical cost convention as modified by the inclusion of investments at market value. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their affiliation to another body, nor those which are informal gatherings of church members.

b Funds accounting

Funds held by the PCC are:

Unrestricted funds - general funds which can be used for PCC ordinary purposes.

Designated funds - monies set aside by the PCC out of unrestricted funds for specific future purposes or *projects.*

Restricted funds - a) income from trusts or endowments which may be expended only on those restricted objects provided in the terms of the trust or bequest; b) donations or grants received for a specific object or invited by the PCC for a specific object. The funds may only be expended on the specific object for which they were given. Any balance remaining unspent at the end of the year is carried forward as a balance on that fund.

Endowment funds - funds the capital of which must be maintained; only income arising from the investment of the endowment may be used, either as restricted or unrestricted funds, depending on the purpose set out in the terms of the original endowment.

c Income and endowments

All income and endowments are accounted for without deduction for any costs of receivability, are recognised when there is evidence of entitlement, receipt is probable, and the amount can be measured reliably.

Donations and legacies

Collections are recognised when received.

Planned giving receivable is recognised when there is evidence of entitlement, receipt is probable, and the amount accords with the Gift Aid declaration or other record of intention to donate.

Gift aid recovered is recognised when the income to which it is attached is recognised.

Grants and legacies are recognised when the formal offer in writing of the funding, is received by the PCC.

Charitable activities

Fees for weddings and funerals are recognised when the events are in the accounting year and receipt is probable.

Other trading activities

Trading activities are where income is receivable in return for selling goods or providing services. Income from trading is recognised when received.

Investment income

Interest entitlements are accounted for as they accrue.

All other income

All other income is recognised in accordance with the above overall policy.

Gains and losses on investments

Realised gains are recognised when the investments are sold. Unrealised gains and losses are accounted for on revaluation at 31 December.

d Expenditure

Expenditure is accounted for on an accruals basis and accounted for gross.

Grants

Grants and donations are accounted for when paid over, or when awarded where the award creates a binding obligation on the PCC.

Church Activities

The diocesan parish contribution is accounted for on an annual basis, reflecting the allocation set by our Deanery. Any parish contribution unpaid at 31 December is provided for in these accounts as an operational (though not a legal) liability and is shown as a creditor in the balance sheet.

e Fixed Assets

Tangible fixed assets

Consecrated and beneficed property of any kind is excluded from the accounts by s.10(2) of the Charities Act 2011. Movable church furnishing held by the Vicar and Churchwardens on special trust for the PCC and which require a faculty for disposal, are accounted as inalienable property unless consecrated. They are listed in the church's inventory which can be inspected but are not included in the financial statements. For other property acquired prior to 2010 there is insufficient cost information available and therefore the cost of such assets is not stated in the financial statements.

All expenditure on consecrated or beneficed buildings and individual items costing under £1,000 are written off in the year they were incurred.

Depreciation

Depreciation is calculated to write down the cost of tangible fixed assets, excluding freehold properties, over their expected useful lives. The rates generally applicable are:

Fixtures and fittings	20%
Audio visual equipment	33%
Office equipment	25%

No depreciation is provided on freehold property as it is the PCC's policy to maintain these assets in a continual state of sound repair. The useful economic life of these assets is so long and residual values so high that any depreciation would not be material. These assets will be subject to annual impairment reviews. Provision will be made if there has been any permanent diminution in value.

Investments

Investments are stated at market value at the balance sheet date.

f Current Assets

Amounts owing to the PCC at 31 December in respect of fees, rents or other income are shown a debtors less provision for amounts that may prove uncollectible.

Short-term deposits include cash held on deposit either with the CBF Church of England Funds, or at the bank.
