Our aims and purposes as a charity.

The PCC has the responsibility, along with Rev'd Tom Robson, of:

- The promotion of the gospel of the Lord Jesus Christ according to the doctrines and practices of the Church of England.
- Promoting in the parish the whole mission of the church, pastoral, social, evangelistic and, ecumenical.
- Practical support and care for people in the parish, from the youngest to the eldest, irrespective of level of need.
- Providing financial support to those in need and to other organisations with similar objectives.

The council has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016, fully recognising its duty to have due regard to House of Bishops' guidance on safeguarding children and vulnerable adults.

How we planned to achieve our charitable objectives.

When planning our activities for the year, we have considered the Charity Commission's guidance on public benefit and, in particular, the specific guidance on 'charities for the advancement of religion'. For 2023 we planned the following objectives and activities to fulfil our aims:

- Providing accessible worship, to enable as many people as possible to participate.
- Providing Christian teaching to all age groups through Sunday services and mid-week small group activities.
- Developing our Families and Youth Ministry within the Parish.
- Provision of pastoral care for people living in the parish.
- Giving to Christian mission organisations.
- Positively engaging with our community through our coffee shop, Love Southbourne, clubs, groups and local events.
- Maintaining the church and grounds as a focus of village life.

What we achieved in 2023.

(detailed reports follow in the 'Impact' section)

Attendance at worship

The church welcomes members and visitors from the locality and those visiting the area. We firmly believe that the provision of services of worship is a major public benefit of our activities. During 2023, we had an average congregation of 59 at our 10am service and 73 at our weekly (term-time) 4pm all-age service. We also reintroduced a midweek Communion service with an average congregation of 13, and a monthly reflective evening Communion service with an average congregation of 22.

In addition, we provided seasonal services throughout the church calendar, including Taize worship, reflective services, and a mix of opportunities to share the gospel at Christmas and Easter.

Teaching, baptising and nurturing new and existing believers

Across the parish we had 7 baptisms, 2 dedications and 2 confirmations. We have 12 homegroups and Bible study groups, which meet regularly to share and encourage people in their faith.

We offered a number of seasonal and one-off opportunities for people to grow in faith, including an Advent course and joint services with other local churches. Many prayer groups continue to meet throughout the week, in-person and online.

Families and Youth

Our ministry among families and youth continues to flourish, with increasing attendance at our afternoon Sunday service, with groups for toddlers and teenagers. Our fortnightly 'Friday Fellowship' continued to welcome families from across our parish and our toddler group, and links with local schools were strengthened. A full report of the impact of this follows later.

Pastoral Care

Our Pastoral team coordinates home and hospital visits as well as home communions and support to those going through difficult times. We jointly lead two regular services in two local care homes with other local churches. These services are an important benefit for those who are too frail to attend on Sundays.

Mission and Charitable Giving

The gifts from our Harvest Festival were distributed to the Food Bank; the church supports the Food Bank as a point of collection for food donations and also as an emergency distribution point for food parcels. During Advent we raised over £1,000 to provide Christmas gifts to local families going through hard times.

Our parish policy is to give a proportion of our income to Christian charities and missions, locally and globally. In 2023 we supported a wide range of organisations including: 2serve, Emmanuel International, The Mande family, Education West Africa, Concordis, Callum and Rianne Adams, Japan Christian Link, B.E.A.T.S., SIM Malawi, Christian Aid, Tearfund, and Family Support Work.

We also held collections to support the work of the British Legion, Children's Society, and Stone Pillow.

Engaging with our local community

St. John's Church is committed to our local community, our neighbours, schools, families and friends. Located in the centre of the village of Southbourne we are ideally placed to use our buildings and grounds to engage with the local community. Our regular activities include toddlers, children and youth groups; book, craft and film clubs and events for seniors. We hosted a significant Remembrance Day service for the local community and now regularly host a veterans breakfast for the large contingent of exforces personnel who live locally.

Provision of our buildings and grounds for people to enjoy

St John's Church is available for prayer and reflection whenever the centre is open, in 2023 that meant Tuesday to Thursday mornings. St Nicholas, Thorney Island is open all year round; and many people take up this opportunity, as seen in our visitor books.

Our outside space has also been available for Church and community events, including Remembrance Day and a Christian Aid garden party, as well as being utilised by our children's groups. We're grateful to all those who work hard to maintain it.

St John's welcomed Little Stars Nursery, Southbourne Infant and Junior Schools to the church for Harvest and Christmas in 2023. Thorney Island School has also made several visits to St Nicholas.

Impact on Beneficiaries' lives & Group Reports.



This report covers the dedicated work of those individuals who operate the sound desk, the video and other such work to make the techie equipment work, for our two main Sunday services and occasional weddings and funerals. On behalf of the Church we are truly thankful. We are now fully established in our elevated outpost. In the last year we have seen the installation of the new video monitors, which together with a set of 'style guidelines' have improved the clarity of the song lyrics and presentations, even when we are blessed with bright sunshine. Our team is quite small, and would welcome any 'new blood', to ease the rota. Martin Fair.



We currently have 16 active members of the group and continue to meet on the 3rd Thursday of the month at 3pm and 7.30pm. We originally divided into 2 groups because of numbers, but it also allows people to choose the time which suits them best, as both groups read the same titles. We have continued to read a wide variety of books chosen by the members which reflect our differing tastes in literature. There is space in both groups to accommodate new members, so do join us and get reading. *Jenny Bond*.



The Kitchen has been used for various events this year. These include the new monthly Lunch Club, a large Wedding, Friday Fellowship, Funeral Wakes and Sunday coffee. Thank you to all the helpers for giving their time to support these, and many other, events. More people have had kitchen training to help with these occasions. We bought some additional equipment and a new microwave was donated during the year. Visitors from other churches continue to remind us of how blessed we are to have such a well-equipped and well-used kitchen. Barbara Wilson

Coffee Connect

We have been very encouraged this year to see more of our regular visitors returning to Coffee Connect, after having to close during the covid epidemic. We have also had new people joining us. We are open from 9am to 12noon on Tuesdays, Wednesdays, and Thursdays. Tom is usually available on Tuesday and Thursday mornings between 10am and 12 noon to chat with anyone who would find that helpful





We held a MacMillan Coffee morning and raised nearly £400, and a joint fund raising event with Upbeat Southbourne Community Choir which raised nearly £200. You are all welcome to join us to meet up and enjoy a coffee and homemade cake with friends. Thank you to all the Coffee Connect volunteers who are so dedicated to serving our community this way. Craft Club

Following on from our Covid shutdown and loss of several members, we have now restructured in the hope that we meet the needs of our members and reduce the stress on the Team. So far we have been very pleased with the new system. We have about twenty-five regular members.



We meet on the second Thursday afternoon of each month, in the coffee lounge, each bringing our own project. Most bring embroidery, knitting, or anything which does not need too much equipment, and we have a social afternoon with plenty of chat and tea. On fourth Wednesdays, upstairs in the Centre, we have more time and more space and the emphasis is on producing items for others rather than for ourselves. We tend to alternate between machine sewing and paper crafting and are always interested to hear of charities asking for items to be made. Janice Collett

Deanery Synod

Synod met on four occasions, each of which at least some of our representatives attended. Opportunities were taken to welcome into the Deanery the Parish of Fishbourne and Apuldram, their vicar Revd Jessica Reid as Rural Dean, and Revd Tom Robson to Southbourne with West Thorney. Also Bishop Ruth who attended the September meeting. During the year, the Deanery Action Plan was submitted in shortened form – though the approval process was so extended that it had become dated. Though there had been several attempts to provide 'Warm Spaces' during the winter, there had only been a low uptake. The Deanery Prayer Group, initiated by St John's, has continued to meet peripatetically on the first Tuesday of each month.

The Deanery had managed to meet its pledged financial contributions to the Diocese in 2023 – for 2024 an increase of 3.4% is anticipated as Diocesan reserves will be drawn on. Several Parishes, having themselves already drawn on reserves, anticipate being unable to maintain even the present level of contributions. There have been discussions about the future of financially unviable Parishes and these have been passed back to the Diocese.

Following debate, Deanery declared support for a private motion to be presented to General Synod declaring 'that bullying is unacceptable behaviour within the Church of God whether by Clergy or laity'. The intention being to restore a balance of responsibility. Deanery Synod noted that General Synod had agreed that a standalone service of blessing for same sex partnerships should be available on trial until 2025. However, at that point there was no approved liturgy, nor was there advice for those who felt unable to offer such blessings. Safeguarding issues are always on the agenda and attention has been drawn to Training Modules required for those with safeguarding responsibilities. *Tim Marsden*

Environmental Group

The Eco group has focused on the garden, making it more bee-friendly by planting wild flowers and taking part in No-Mow May. Our thanks to the dedicated team of mowers who mowed appropriate paths round the church, and to the people who turn the waste into such good compost. In the kitchen and centre we have moved away from single use items and minimised food waste. We thank everyone who has joined with these initiatives as they wouldn't otherwise be successful. Fabric (Warden's Report)

In 2023 we have improved the safety and security of our buildings with the installation of a new security and alarm system. In the church, using a generous donation, we installed new digital screens which have improved the clarity of slides and videos used in worship. We are grateful to the volunteers who help keep our church building and grounds safe and in good condition. Looking forward, we are awaiting a quinquennial inspection in 2024, we are raising funds to refurbish our organ and are developing plans to use our church centre more effectively. Gill Prosser

Film Club

The Film Club continued to meet on the 2nd Tuesday of the month at 2pm during 2023, showing a range of films. There is no charge but donations are often made, and there's a break for tea and cake.

Homegroups

A new homegroup was started in the Autumn of 2023 in one of the new housing areas in the parish, bringing the number of groups to 8. This group meets on term time Thursday evenings and has 7 members. Last year it was noticed that most groups met on a Monday and precluded those for whom that day was not convenient. One Monday evening group has since changed to a Wednesday evening. This means that we have groups meeting on each day except Friday. Two meet in the morning, one in the afternoon and five in the evening with approximately 51 members.

The Wednesday morning Bible study continues in the lounge in the Centre and also a small nurture group meet in the prayer room at the same time. Many of the groups are at near capacity as most meet in members' homes, but they are places where we can grow spiritually together and give each other encouragement and support. I would ask for ongoing prayers for the groups meeting and also that there would be a desire for others to join so that new groups would be needed in the coming year. *Carol Jones*



Love Southbourne last year had three main events. We distributed Hot Cross Buns on Good Friday at different points around Southbourne. These were received really well and people felt blessed by receiving them. The other two events were doing a BBQ for the Village Fete at the Recreation ground and taking a Christmas Trailer to Priors Orchard estate and up round the Alfrey Road houses. Safeguarding Report

Last year ended in the completion of all the DBSs being transferred from 5yrs to a 3yrs status with most people registering for update service. This was achieved well in advance of the diocese deadline January 2024. The diocese was informed and replied: – "Many thanks for letting us know, and well done! As you say this has clearly been a very big task but it's great that you've got it done. Excellent work!"

Safeguarding training is running smoothly with volunteers updating training as and when needed. Thank you to everyone for your cooperation and willingness. This makes our church a much safer place for all. All volunteers and staff members have gone through safer recruitment, the necessary training and induction into the role. Safeguarding continues to be a standard item on every agenda of the PCC meetings as all PCC members are responsible for safeguarding. All safeguarding concerns raised were responded to and dealt with appropriately. However, we need to maintain our vigilance to ensure protection and well-being of everyone in our parish. *Christine Liddle*.



Social Team has had two big events in the past year. These were the Bishop Ruth Ladies evening and the Harvest Lunch and were both attended by about 90 people. We have also been helping out at other events like Christian Aid and the Christmas Celebrations. We have 11 people on our team and we always enjoy putting on these events but would always welcome new members! I would like to thank all those on team and those who are not on team but do help with the clearing up afterwards. Susie Bartlett









We entered 2023 with a not so new Padre, Rev'd Nick Todd, who had been with us some 13 years before. From his time in the Gulf with U.S. Padres, he brought a personal approach to the sharing of communion which has continued to inform our practice over the year.

We celebrated Mothering Sunday distributing posies as in pre-pandemic years. We added a Sea Sunday service in July, which our congregation enthusiastically supported with readings of shipwrecks, sea-shanties and a collection for Mission to Seafarers (£125). We repeated our Harvest Festival theme in collecting for Chichester Food Bank (£90). Our year was punctuated by occasional services returning to normal frequency with 3 baptisms, 2 funerals and 2 committals during 2023. This creates opportunities to preach and demonstrate our Christian values. Our congregation numbers remained strong (by our measure). Folk from St John's who had made the journey down to join us during its closure continued to appreciate our fellowship.

Padre Nick retired from the Army in July that year, so we invited Rev'd Barbara Stanton along for parish communions through bloc leave before Padre Mike Jenkinson joined us in September. Our congregation were heartened to see more of Rev'd Tom as he got to know where we were and how we did things. I am pleased to report that the St Nicholas 2021 Quinquennial Report repairs got underway in October. Our repairs were concluded by December at £11,628 and the sluice gates' repair by the week before Christmas, enabling our Crib Carol service to go ahead as planned. *Andy Walkley*





The intrepid walkers have continued to go out despite the weather, which this winter has made our favourite paths so muddy. We are fortunate to live in such a beautiful part of the country, and 6-10 of us walk mostly on the South Downs or around the Harbour, with lively conversation, views, wildflowers, a bit of exercise and cake! Worship

During the year we were pleased to welcome additional singers into the 10am singing group. This enabled us to bring a greater variety of music to the morning services, e.g. during Communion, and also sing 4-part harmonies most weeks. In addition to the morning services, we also sang a number of Taize services throughout the year, and this more reflective style of music has resonated with the congregation, who have been appreciative of the atmosphere created by this form of worship. In September 2023 the PCC agreed a fundraising campaign to raise £23,000 to overhaul the organ and bring it up to modern standards. This campaign is now in progress, and we are optimistic that the renovation can be carried out during 2024. Mike Prosser

4YG

4YG stands for 4pm Youth Group. 4YG is a discipleship youth group within the 4pm service. Up until recently 4YG had been led by Rachel & Dylan but with the arrival of their first baby it is now being led by Tina, Sue, Karen, Stuart, Mark, Michelle and Richard. An intentional change to 4YG is that the group theme now mirrors the 4pm service. This is so that families have heard the same message, albeit in an age specific way, and so can talk about it together at home.

Friday Fellowship

Friday Fellowship is a provision for all the family! The aim of Friday Fellowship is to deepen the relationships between the families who attend the 4pm service as well as being a 'stepping stone' from groups like Thursday Tots into the wider life of the church. We regularly see between 40 - 50 people attend on a biweekly rotation.

A fairly recent addition to Friday Fellowship has been the inclusion of focus groups for all age groups. These include:

(1): Pre-school to School year 3

(2): School year 4 - 6

(3): Secondary school provision called the LOFT.

A year on, High Tide has become a staple part of St. John's youth where we take anything from three to seven young people each month. Schools Work

We've really built on the already established schools work in 2023. We are now having monthly assemblies at Southbourne Infant school, Southbourne Junior School & Thorney Island Primary school. May Camp

I feel like MayCamp 23 went slightly under the radar. It was so exciting to be able to take four young people to MayCamp for the first time last year. MayCamp is a diocese wide annual youth event which takes place over the last bank holiday weekend in May.

We were able to go in 2023 because Richard & Kim created a MayCamp collaboration between Immanuel Church in Chichester, St Paul's Church in Chichester, St Nicholas & St Mary's Church in Lavant and St. John's. This meant that we had an excellent number of young people and a great team grafted together from these churches. It was so much fun! The young people had a blast and from Richard & Kim's perspective it was great to share the responsibility of the event with other youth workers and volunteers.

We are looking forward to taking six young people from St. John's this year.

Summer Camps

2023 was the summer of camping for St. John's! As well as MayCamp Richard & Kim were so pleased that so many people from St. John's went to New Wine in the Summer. Thank you so much to Tom for sending us on our way by praying for us. We all had a fantastic time albeit a bit squashed. FINANCIAL REPORT

The trustees present their financial report for the year ended 31st December 2023.

Total income for 2023 declined further to £183k, reflecting sharply lower grants received during the year. Although donations rose slightly to £154k, this was mainly due to a large donation which was received towards the end of the year in connection with the upgrade of the audio visual equipment in the church building.

Total expenditure continued to increase in comparison to 2022 to £221k, reflecting spending on mission giving as well as the upgraded audio visual equipment, in particular some large, easily seen new screens.

The resulting deficit increased very substantially to £38k which is unsustainable, given available reserves. As noted last year, the expected increases in cost of living and higher costs which the PCC has incurred have put downward pressure on income and upward pressure of expenditure. The short term outlook continues to be challenging, although the PCC is working on fundraising (including encouraging the use of a recently purchased pay station) and grant applications to improve the situation.

Unrestricted funds registered a significant deficit (£23k) as did restricted funds (£15k).

The PCC has established a budget which anticipates a modest deficit for 2024, with plans to reduce spending on building repairs and maintenance, while maintaining spending in the areas of Families & Youth, as well as local and overseas mission. This should allow us to focus resources on the PCC's core objectives.

We are most grateful to the many church members who give sacrificially to meet the costs incurred by the PCC, the bulk of which are making Parish Share contributions to the Diocese (to meet ministry costs, salaries, housing, etc.), and to pay staff salaries.

Risk management

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

Reserves

The trustees have a policy to hold cash reserves of at least £25,000 to cover liquidity needs.

Trustees' Responsibilities

Charity law requires the trustees to prepare financial statements for each accounting year which give a true and fair view of the state of the charity and of its income and expenditure for the year. The trustees are required to:

- 1. Select suitable accounting policies and apply them consistently
- 2. Make judgements and estimates that are reasonable and prudent
- 3. State whether the applicable accounting standards have been followed, subject to any material departures disclosed and explained in the accounts.
- 4. Prepare the financial statements on a going concern basis unless it is inappropriate to presume that the charity will continue in business.

We are responsible for keeping adequate accounting records which disclose with reasonable accuracy at any time the PCC's financial position and enable us to ensure that the financial statements comply with the Charities Act 2011. We also have a responsibility to safeguard the assets of the charity and to take reasonable steps to prevent fraud or any other irregularities.

INDEPENDENT EXAMINER'S REPORT

I have examined the accounts for the year ended 31st December 2023 on pages 23 to 30 which have been prepared on the basis of the accounting policies set out on page 26.

Respective Responsibilities of Directors/Trustees and Examiner

The trustees of the charity are responsible for the preparation of accounts; they consider that the audit requirements under section 144 of the Charities Act 2011 do not apply but that an independent examination is needed. I have been appointed to conduct an Independent Examination required by section 145 of the Charities Act 2011 and to report in accordance with the regulations made under section 145 of that Act. It is my responsibility to examine the accounts, without performing an audit, and to report to the trustees.

Having satisfied myself that the charity is not subject to audit and is eligible for independent examination, it is my responsibility to:

- 1. examine the accounts under section 145 of the Charities Act 2011;
- 2. follow the procedures laid down in the General Directions given by the Charity Commission under section 145(5)(b) of the Charities Act 2011; and
- 3. state whether particular matters have come to my attention.

Basis of Examiner's Statement

This report is in respect of an examination carried out under section 145 of the Charities Act 2011, and in accordance with the general directions given by the Charity Commissioners. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes a review of the accounts and making such enquiries as are necessary for the purpose of this report. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently no opinion is given as to whether the accounts present a "true and fair view" and the report is limited to those matters set out in the statement below.

Independent Examiner's Statement

Based on my examination, no matter has come to my attention which gives me reasonable cause to believe that in any material respect, accounting records have not been kept in accordance with section 130 of the Charities Act 2011, or that the accounts presented do not accord with those records, or comply with the accounting requirements of the Charities (Accounts and Reports) Regulations 2008 other than any requirement that the accounts give a 'true and fair' view, which is not a matter considered as part of an independent examination.

No matter has come to my notice in connection with my examination to which, in my opinion, attention should be drawn to enable a proper understanding of the accounts.

Accounting Policies Accounting Convention

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value. The financial statements have been prepared under the Church Accounting Regulations 2006 as far as currently applicable, in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their financial statements in accordance with the Financial Reporting Standard applicable in the UK (FRS 102) issued in October 2019 (SORP 2019 (FRS 102)), the Financial Reporting Standard applicable in the UK (FRS 102) and the Charities Act 2011. Under FRS 102, the PCC falls within the definition of a public benefit charity.

1.2 Income

Donations and planned giving are recognised when received. Income tax recoverable on Gift Aid donations is recognised when income is receivable, provided that income tax is reasonably certain to be recovered. Grants are recognised when the conditions for receipt have been met. Investment income is accounted for in the period in which it is earned and when the amount can be measured reliably. Other income is accounted for on a receipts basis.

1.3 Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the PCC to that expenditure. Accordingly, accruals, creditors and provisions are recognised where the PCC has a present obligation and where the future out flow of funds is probable. Grants and donations for the financial year are accounted for when a decision has been taken to support a particular ministry. The PCC provides a contributory defined contributions pension scheme for its employees, in line with current legislation.

1.4 Fund Accounting

Unrestricted funds represent the funds of the PCC that are not subject to any restriction on their use. Restricted funds are funds which have been donated for specific purposes. The purpose and use of the restricted funds are set out in Note 10 below.

1.5 Tangible fixed assets

Consecrated and beneficed property is excluded from the financial statements in accordance with section 10(2) of the Charities Act 2011. No value is placed on assets held by the churchwardens on special trust for the PCC and which require a faculty for disposal, since the PCC considers this to be inalienable property. All expenditure incurred during the year on consecrated and beneficed buildings and movable church assets, whether maintenance or improvement, is written off when incurred. Other tangible fixed assets have been written off, in view of their low value.

1.6 Current assets

Debtors represent amounts due to the PCC and prepayments. They are recognised at either the settlement or prepaid amount. Cash at bank comprises bank current accounts and cash-equivalent bank deposits.

1.7 Taxation

The PCC, as a registered charity, is generally not liable to taxation on its surplus or capital gains.

1.8 Cash flow statement

The PCC has taken advantage of the exemption provided by the FRS 102 SORP and has not prepared a Cash Flow Statement for the year.

1.9 Going concern

After making appropriate enquiries, the PCC members have a reasonable expectation that the PCC has adequate resources to continue in operational existence for the next twelve months. For this reason the PCC has continued to adopt the going concern basis in preparing the financial statements.

3. Other activities

Income from other activities was mainly fees charged for weddings and funerals held at our churches, hire charges from other users of our premises and income from certain social events.

4. Investments

Investment income arose from interest paid on deposit balances, mainly by CCLA.

Other income includes insurance claims totalling £263 paid by the PCC's insurance company.
